16 your call (Inaudible)...

19 DW No that's alright urn, just trying to piece everything together and make sure the

20 information I give to the lead detective is accurate.

21 KC Yeah.

22 DW I know we talked about, you were talking to the ah...

23 KC Casey...

24 DW ...you were talking about a different Casey.

25 KC Yeah.

DW Was it Casey Williams that called and asked to borrow money? Or was it..

3 DW Okay. Do you have her phone number where I can call..

4 KC Well the number she called me from I've tried calling back and no one answers.

5 DW Uh-huh. (Affirmative)

6 KC So, hang on just one second.

7 DW Okay.

8 KC I had it pulled up on my phone. Let me see.

9 DW Did she ever borrow, did you ever loan her the money?

10 KC No I never met up with her.

11 DW Okay.

12 KC She said she was leaving, she's leaving her boyfriend because he's been beating

13 her and ...

14 DW Really?

15 KC ...a whole bunch of drama. And I gave her, I gave her your...

16 DW (Inaudible)...

17 KC ....number.

18 DW She needs to call and put him in jail.

19 KC Yeah she... her mom told her to come home so. Um, I have...

20 DW Go ahead.

21 KC ...407...

22 DW Uh-huh. (Affirmative)

23 KC ...856-8405. And when she called me she said she wasn't at home so.

24 DW Okay.

25 KC I don't know whose phone she was using.

DW Does her boyfriend..

<sup>3</sup> DW .... answer that phone to if I leave a voice mail message is that gonna cause a  
<sup>4</sup> problem?

<sup>5</sup> KC Well I, when I've called it just rings and rings and rings and rings.

<sup>6</sup> DW Oh okay.

<sup>7</sup> KC So, I don't know where she was calling me from unless it was one of her friends  
<sup>8</sup> that doesn't have an answering machine or something. But it's 2008 who  
<sup>9</sup> doesn't have an answering machine...

<sup>10</sup> DW Yeah.

<sup>11</sup> KC ...for crying out loud.

<sup>12</sup> DW Or a voice mail or something. So, do you know if that's a cell phone number for  
<sup>13</sup> her, is that a house number?

<sup>14</sup> KC I really don't know.

<sup>15</sup> DW Alright 'cause I don't want to... ah, I don't want to cause her more problems than  
<sup>16</sup> she's already got if you know a man's calling. I don't really want to leave her a  
<sup>17</sup> message saying hey this is the police.

<sup>18</sup> KC Well when I...

<sup>19</sup> DW Call me.

<sup>20</sup> KC I'll tell you what when I called no one answered the phone so.

<sup>21</sup> DW Okay.

<sup>22</sup> KC You might get the same exact response that I do.

<sup>23</sup> DW How old a person is Casey?

<sup>24</sup> KC Casey, that Casey.. wait which Casey are you talking about Casey Williams?

<sup>25</sup> DW Casey Williams.

1 KC Um, I think she might be 23, 24.

2 DW Twenty-three.

3 KC 'Cause I think she had, she had Abby when she was 17.

4 DW Okay.

5 KC I think.

6 DW She go to Colonial or Boone or...

7 KC No I met her at Disney World when I was working at Disney a while back ago.

8 DW Okay.

9 KC So, um, speaking about theme parks. I remember going through gate 2 with

10 Casey.

11 DW Which one?

12 KC The other Casey.

13 DW When?

14 KC Casey Anthony. This was when I was still working at the Hulk. So, the only way

15 to get backstage.

16 DW Uh-huh. (Affirmative)

17 KC Through gate 2, is if you have an I.D.

18 DW Right.

19 KC And I remember her having an I.D., in her hand 'cause she.. the guy scanned it.

20 DW Yeah she used to work there.

21 KC Okay.

22 DW A while back. But that was, that was a ways, long time ago wasn't it?

23 KC Yeah.

24 DW Yeah.

25 KC It was back when I worked at the Hulk. So that would've been oh gees, '04, '05.

1 DW Yeah.

2 KC I want to say.

3 DW Yeah.

4 KC Or maybe... yeah. 'Cause I worked at Hulk a while ago so.

5 DW Do you know ah, Casey Williams' last address she lived at?

6 KC No.

7 DW No.

8 KC To be honest with you I know she lived in an apartment at point behind the Magic

9 Kingdom, I think she told me, but...

10 DW Is she a white female?

11 KC Huh?

12 DW Is she a white female?

13 KC No, she's African American.

14 DW Okay. Alright, well I'm gonna try to call her. I appreciate you calling me back.

15 KC Ah...

16 DW And I think that was all I needed to clear up just make sure that she was the one

17 that was .. that you were gonna loan the money to not Casey...

18 KC Yeah.

19 DW ..Anthony.

20 KC No.

21 DW Okay.

22 KC 'Cause I know when she had asked me she said that she... her mom had just

23 sent her a Best.. ah, not a Best Western not the hotels. But urn, ah, what's it

24 called? Shoot, where people send you money to the...

25 DW Western ...

KC ...internet or something.

<sup>3</sup> KC I guess so yeah.

<sup>4</sup> DW Yeah.

<sup>5</sup> KC I don't know.

<sup>6</sup> DW Yeah wire...

<sup>7</sup> KC So she could...

<sup>8</sup> DW ...it to her.

<sup>9</sup> KC Yeah so she could get some money so she can go home.

<sup>10</sup> DW Where's home for her? A different state?

<sup>11</sup> KC I know she had told me back in the day I think her mom either lives in Alabama or

<sup>12</sup> Georgia one of the two.

<sup>13</sup> DW Really. And...

<sup>14</sup> KC So, I know she lives out of state so.

<sup>15</sup> DW Let's...

<sup>16</sup> KC I know her daddy died back... he actually died December the same year my

<sup>17</sup> grandfather died. So, that would've been December of '04.

<sup>18</sup> DW Wow.

<sup>19</sup> KC Yeah.

<sup>20</sup> DW Let's...

<sup>21</sup> KC I remember that...

<sup>22</sup> DW I have ah... hm I got a Casey, Casey Williams in Panama City. Casey Williams

<sup>23</sup> in Umatilla. A Casey Williams in St. Petersburg and a Casey Williams in

<sup>24</sup> Lauderdale. She must not have a Drivers license from here.

1 KC I don't think she actually drove to be honest with you. She took the bus  
2 everywhere. She took the Lynx.  
3 DW Did she.  
4 KC Yeah.  
5 DW Alright, we...  
6 KC So...  
7 DW ...Kio, I appreciate it if you get anything else if you think of anything please call  
8 me.  
9 KC I will.  
10 DW Alright.  
11 KC If anything call me. You got my number.  
12 DW I talk to Mr. Bailey, Bailey..  
13 KC Did you?  
14 DW Yeah, he sounds like a nice, nice gentleman.  
15 KC He's a sweetheart I love that man to death.  
16 DW Yeah.  
17 KC If I ever, if I ever got in trouble and I did something stupid that'd be the man I go  
18 to.  
19 DW He spoke highly of you so I reassured...  
20 KC Yeah he...  
21 DW ...him that you took his advice and spoke with me and he was all thankful and  
22 he's a nice man.  
23 KC That man honestly to be honest with you, he's more of a father than my own  
24 father was.  
25 DW Yeah.

1 KC So.  
2 DW Alright. KC Yes sir. DW Okay Case.. I mean  
3 Casey... Kio, thank you.  
4 KC (laugh)  
5 DW I'm so confused.  
6 KC Oh God I'm sorry hon.  
7 DW Alright.  
8 KC Well you take care of your self alright?  
9 DW Alrighty. Bye-bye.  
10 KC Alright, bye.
